## Two copies of this application and any attachments must be supplied.

Before approaching the NRA and making payment, the applicant should decide how many separate items of information the enquiry relates to. A fee is payable in respect of each item (refer to Form A1 of First Schedule).

A fee is still chargeable even where the enquiry proves negative and no certificate is issued.
