

Cancellation of Mineral Rights

Date : May 27, 2016

The general public will recall that on the **13th August 2015** the Ministry of Mines and Mineral Resources and the National Minerals Agency issued a press release urging some Mineral Right Holders (exploration and mining companies) to fulfill their obligations under specific provisions of the Mines and Minerals Act of 2009. Despite repeated warnings, some of these Mineral Right Holders have failed to comply.

The Ministry of Mines and Mineral Resources and the National Minerals Agency hereby inform the general public that, consistent with the provision of Section 53 of the Mines and Minerals Act of 2009, the Licences of the under-mentioned have been cancelled with immediate effect.
